The law relating to tax can simply be unclear due to ambiguity about the detail or application of particular measures and the language used in tax legislation. Success is about so much more than plugging in numbers - it starts with a strong understanding of the industry, business trends, and regulations. Many people, with the exception of tax barristers, have to admit that they have almost no idea what a particular piece of law has been proposed to deal with, and why, or what it might mean. Some UK tax barristers are qualified to practice in New York, Canada, South Africa and the Republic of Ireland. Every tax ought to be so contrived as both to take out and to keep out of the pockets of the people as little as possible over and above what it brings into the public treasury of the state. Some tax barristers have skill and experience in advising on “back duty”; negligence by tax professionals and judicial review of unfair actions by HMRC. They also undertake tax litigation in foreign common law jurisdictions and at the European Court of Justice. Businesses need to observe the regulations relevant to their industry. This can bring them into contact with regulators, either by reporting on their progress in observing regulatory standards or facing an investigation on suspicion that the regulator’s code of practice has been breached. UK tax barristers advise upon the tax-efficient structuring of transactions as well as more general tax planning for taxpayers ranging from large multinational companies and groups to private individuals and estates. If you are not domiciled in the UK, under English common law, you are now treated as domiciled in the UK for all tax purposes. Disclosures by third parties e.g. the Panama Papers and the Paradise Papers and how to manage may be matters which an accomplished tax barrister may advise upon.
